

2026 Member's Exhibition

February 6 – March 13, 2026

ELIGIBILITY: This juried exhibition is open to all members in good standing, of Starkweather Arts Center. Original works, in any medium, are eligible. Works previously shown at Starkweather's Member's Exhibition will not be considered for this exhibit.

GUIDELINES: This exhibit is planned to be in the gallery, with some pieces to be featured online in social media.

Artists can submit up to 2 entries for this show. An entry fee of \$25, for up to 2 pieces, is required to assist with publication and administrative costs. Art must remain in the gallery until the ending date of the show.

Two dimensional artwork may not exceed 40" x 40", (including frame). Work must be properly framed, with no exposed glass edges; wired and ready to hang. Saw tooth hooks are not accepted. Three dimensional works may not exceed 48" in all aspects.

Artist name & title of work must be securely attached to the back of the framed work or bottom of the piece.

Starkweather reserves the right to reject any entry which is unsuitable in size or fragility, does not meet the guidelines, or is deemed unsuitable. Please direct questions to us at 586.752.5700 or starkweatherarts@comcast.net.

A commission of 30% will be deducted from the sale price of artwork sold. All artwork submitted must be available for purchase. If you are not willing to sell the artwork, do not submit it. Artist is responsible for shipping costs to & from gallery, if accepted art is shipped.

Submission of work shall constitute an agreement to comply with all conditions set forth in this prospectus. The show's juror reserves the right to final selection of accepted work. All accepted work will remain as placed by Starkweather and may not be withdrawn before the exhibit's close. Work may be published on Starkweather's social media.

All entries will be handled with all possible care, but Starkweather is not responsible for loss or damage. Permission to photograph accepted work for publicity shall be understood to be granted unless specifically denied.
